- b. Our goal is a systematic approach to provide behavioral health services to all residents in San Miguel County
- c. While programs can be targeted to specific communities, funds must be equitably spent throughout San Miguel
- b. Continued Discussion on the name of the panel group decided on but did not formally vote.
 - i. San Miguel Behavioral Health Solutions
- 4. Update on Environmental Scan
 - a. TCHNetwork provided an update on their progress of the environmental scan. Including list of interviewees
 - b. Discussion around focus groups
