1) Approve January Meeting Minutes

2) CORE/Co Responder Update

- Sheriff's department has taken over the contract for providing jail-based and co-responder services under the DOLA grant; minimal information available at present regarding future services under the Sheriff's department
- b) Discussion re: models of programs in place
 - i) Providing clinical oversight to co-responders
 - ii) Direct access to higher acuity services
 - iii) Summit County is going the same direction and reports of challenges creating linkages to crisis services, etc.
 - iv) Office of Behavioral Health provides funds for co-responders in Montrose and Delta
 - v) DOLA funds co-responders in San Miguel and Gunnison Counties
 - vi) The Center for Mental Health is redeploying Melissa King to provide other services in County

3) Funding Brainstorm

- a) Discussion about specific funding grants to individuals or organizations to provide services
- b) Reviewed other models including Strong Start, Energy Outreach Colorado, Good Neighbor Fund
- c) Concerns and issues raised around
 - i) Funding individuals

 - iii) Who provides oversight for the dollars?
 - iv) General consensus around:
 - (1) funding organizations and/or licensed professional therapists and not funding individuals directly
 - (2) Payor of last resort
 - (3) Citizens of San Miguel County
 - v) Which organizations might be eligible: CMH, TRMC, UMC, TCHNetwork
 - vi) Explore this as a pilot program-set up interim meeting on 3/12/2020 via ZOOM
- 4) Overview of current funding status
 - a) Cash balance with the treasurer at year end 12/31/19 is \$615,847.42
 - b) Revenue received was \$634,066.28 with \$18,218.86 in expenditures (treasurer fees)
 - c) Anticipated property tax revenue for 2020 is \$663,165.
