 - i. Notably in the 20–30-year-old age group
 - ii. Anticipates more due to housing insecurity

- d. Clinicians in the collaborative noted difficulties brining clients back in person
- e. Jenny Wheeler noted that the Center for Mental Health is only accepting Medicaid but is willing to work through financial barriers
