**2. Current Updates**

- a. Good Neighbor Fund
  - i. Paul (TCHNetwork) explained to panel the amount of money that has been spent through the Good Neighbor Fund for behavioral health funds in San Miguel
    - 1. Discussion around the current level of funding requested by community and if panel needs to ramp up advertising efforts to raise awareness to apply for these funds
    - 2. Advertisements in Telluride papers will continue. Encourage organizations to spread the word to other organizations about this fund
  - ii. Discussed the potential for an additional group to form to supplement the group that addresses unmet needs in San Miguel
    - 1. Potential for Mental Health unmet needs subgroup
    - 2. Potential for a Substance Use unmet needs subgroup
    - 3. Paul, Carol F. and Amanda J. will discuss possible approaches
- b. Agency Funding Pilot
  - i. Interested agencies to expect grant report in early July and due in early August
  - ii. Once applications are submitted, the panel can access how monies will be employed
- c. School Based Services Grant
  - i. Draft of grant was sent to Carol F. and Mike G. for review prior to sending it to the Telluride and Norwood school districts
    - 1. Discussion occurred around changing this grant to be a one-time funding option instead requiring schools to spend all of the monies in year 1 to allow schools to be able to have the chance to successfully implement programs the grant is intended for
  - ii. Motion to approve School Based Services Grant to now be a one-time release of funds to schools to be used in a designated time frame
