a. Solutions Panel reviewed current budget to inform decision making process

4. School Based Annual Report Presentations

a. Presentation for Norwood Public Schools given by Kim Fischer

- i. Kim Fischer is the high school English and Spanish teacher and the lead for the Norwood school-based grant for Restorative Practices. Norwood is rolling out Restorative Practices through a 3-year process. This is normally how the school district implements new programs.
- ii. See attached PowerPoint that was shared during Presentation.
- iii. Rob Whiting inquired on how the Norwood team is working with teachers and staff who have trouble implementing Restorative Practices. Kim explained the tiered level of support the team offers to staff members.
- iv. Rob Whiting asked about the underlying issues that has led to high staff turnover at the school and for the restorative practices team.
- b. Telluride School District presentation given by Alex Jones
 - i. Alex Jones is the 11th and 12th grade school counselor, department head, and lead for the Social Emotional Learning program. Telluride School District conducted multiple professional development sessions to improve the capacity of district staff. Telluride also conducted surveys of student to assess mental health well-being, which revealed an increase in suicide ideation. Counselors also reported this in their sessions with students.
 - ii. The Telluride School District invested in Source of Strength training, which Alex attended, and will continue to trickle that down to district staff.

John Pandolfo explained how the district now has 4 FTE counselors and revised the structure so there is a counselor dedicated to specific grade levels.

5. Crisis Services Annual Report Presentation

- a. Jennifer Dinsmore is the chief administrative officer for the SMC Sheriff's office and presented on the Crisis Services Annual Report.
- b. The sheriff's office is looking to rehire for a CORE responder, as they recently had a resignation.
- c. See attached PowerPoint that was shared during Presentation.
- d. The sheriff's office has seen the expansion of its services through the implementation of the grant and is looking to expand clinicians covered by this grant to 1.5. Jennifer and Corinne will further discuss a new funding application.
- e. Rob Whiting expressed his support for the positive impact the program has had and wants to further discuss the scope of the program.

6. Telluride School District Application for funding for through Dec. 2021

- a. Corinne Cavender elaborated on the circumstances of the funding request and receiving the application from the school district. The school district will resubmit their application in December as part of Panel's effort to align with the County government's fiscal year.
- b. John Pandolfo reiterated the options he shared via email for altering aspects of the grant that the Panel expressed reservations on funding allocated to participating to the college fair.
