Meeting was called to order at 9:10AM

1. Approve May 28, 2020 Meeting Minutes

- a. 1st Nicole Long
- b. 2nd Sarah Landeryou

2. Current updates

- a. Good Neighbor Fund
 - i. Through GNF, the panel has funded 11 individuals for \$15,540
 - 1. The majority of these dollars have been allocated to individual therapists providing individual therapy sessions
 - ii. The behavioral health funds through GNF are still being advertised in the Norwood Post and the Telluride Daily Planet; a new ad was created to provide for a different look
- b. Agency Funding Pilot
 - i. TRMC funding status
 - 1. So far, TRMC has only spent about 10% of their grant
 - 2. Possibility is present to apply for more funding
 - 3. Must spend down current funds before applying for additional funds
 - ii. School based SEL grant
 - 1. Grant requests have been received from both the Telluride school district and the Norwood school district.
 - 2. Paul provided the panel with a summary of the two grants in the meeting packet
 - a. Norwood plans to expand current social emotional learning
 - b. Telluride plans to focus on implementing a district-wide social emotional learning curriculum
 - 3. Both requests were approved by Paul per Panel instruction
- c. **Crisis Services Response Grant**
 - i. San Miguel Sheriff
 - 1. Discussion regarding the sheriff's grant request. Some panel members were concerned about other funding sources the sheriff's office might have access to. Decision was made that the panel cannot discriminate against an entity because of other possible grants it may receive
 - a. *Motion by Sarah Landeryou to approve the Crisis Services Grant submitted by the San Miguel County Sheriff's Office in the amount of \$59,556.00*
 - b. 2nd by Nicole Long
